massive 10 000 workers have lost their jobs in the ailing clothing and textile industry since the beginning of this year, with more expected to be sent home packing in the near future.

The sector, which is the second largest employer after the government, continues to perform poorly largely owing to declining orders from the United States, the major importer of Lesotho's apparel.

Devastating effects of the Covid-19 are also still being felt as desperate local firms close shop or lay off employees for months on end hoping that the industry will gradually pick up. Buts this is unlikely, experts say.

Local companies this week painted a gloomy picture of the industry and expressed fears the job losses are likely to continue as there is no end in sight to the current challenges.

Russia's invasion of Ukraine in February 2022 has also worsened the textile industry's quagmire in the past two years as orders dwindle further due to lack of demand for Lesotho's apparel.

The regional manager of Lesotho Precious Garments (PTY) Ltd, Lengana Tšepe, told *theReporter* in an interview on Tuesday that the company was limping.

Tšepe said the ongoing economic meltdown affecting both African and Asian countries, which was precipitated by the Russia and Ukraine war was impacting negatively on the Maseru based company.

He said Americans have reduced their spending on clothing and were instead now focusing on basic needs such as food, whose prices continue skyrocketing due to the war. Russia and Ukraine are two of the world's biggest producers of wheat which they export to many countries including Lesotho.

"American consumers who buy most of Lesotho's apparel are now having to make a choice between buying clothes and food; they prioritise food. This has a negative impact on our textile industry," Tšepe explained.

"These and other factors that are beyond the control of the company are severely affecting our business," he noted.

He further expressed fears and there were clear signs that retrenchments in the sector would continue in the country as the dire situation persists for most companies.

"Experts have advised that the crisis is likely to continue for the better part of this year and this is worrisome."

Tšepe said Precious Garments (PTY) Ltd sources materials for its products from Taiwan before exporting them to the United States. But

with transport costs ever escalating, the company was increasingly finding it more difficult to survive.

This has resulted in thousands of people losing their jobs, he said.

"Instead of us making profit, we have made losses," he added.

Lesotho Precious Garments (PTY) Ltd has retrenched 700 workers between March 20 and April 20, 2023.

According to the Lesotho National Development Corporation's (LNDC) Industry Status Report dated March 2021, at least 6064 workers in the clothing and textile sector lost their jobs due to the COVID-19 induced economic meltdown

The report further states from March 2020 to March 2021 factory closures and downsizing immensely contributed towards job lay-offs.

"Two factories namely, Coating Company and Huan Sheng ceased operations, while Presitex and CGM merged. Nien Hsing International combined its five companies into three and is planning to combine the three companies into one," reads the report.

It also notes that lack of demand on the global market had led to widespread retrenchments in the sector:

"Another contributing factor to the job losses is the decline in purchase orders as a result of the Covid-19 pandemic," it added.

The report however, indicates that the textile sector still remains a top employer in the country.

"The manufacturing industry constitutes 88, 8 percent of total employment in the industry despite the 12, 9 percent decline.

"Printing and embroidery sectors experienced the most employment decline of 82, 4 percent as a result of a company that shut down, followed by clothing and textile sector at 12, 9 percent."

Another report titled Impact of Covid-19 on manufacturing Industry in Lesotho: Case study of LNDC- Assisted Companies released in November 2020 highlights that some factories were forced to retrench workers and placing some on temporary layoffs.

"The employment levels for 2020 have been relatively lower compared to the same period in 2019. The lowest employment rate was recorded in April 2020 at 30 741, which is 24 percent lower than the one recorded in the same period in 2019. This decline is due to lockdown and company closures," the report says.

"Some companies were forced to retrench workers while some factory workers had their hours cut during the lockdown. The highest reported employment level was 43 542 in February 2020, which was higher than that of the same period in 2019."

The November 2020 report however re-

vealed that the impact of the COVID-19 lockdown on the production of the manufacturing sector was not as bad as they had anticipated.

It also indicated that the impact of COV-ID-19 lockdown on the manufacturing industry has been minimal and below the levels anticipated. The same report went on to recommend that various relief measures be implemented to reduce the effects of COVID-19 on local companies.

"The need to support and implement trade and trade-related initiatives cannot be overemphasised as the pursuit for the private-sector-led growth can meaningfully be achieved when interventions targeted at empowering and strengthening the operations of the private sector particularly in trade and investments are prioritised.

"The potential to turn around the state of the economy and relief to government challenges that include high deficit and wage bills can be explored through focusing and committing to implementation of relevant business environment reforms to entice the private sector to participate," the report added.

Lengana urged the government to assist the clothing and textile industry with subsidies on electricity and water:

He said although this would not be enough, it would go a long way in helping the struggling factories get back on their feet.

"It would not be helpful for the government to give factories cash bail outs. It would be of no use because additional money will not bring any orders that create or help retain jobs," he added.

Commenting on the huge job losses in a separate interview, the Deputy Secretary of the National Clothing and Textile and Allied Workers Union (NACTWU), Tšepang Makakole, said it was sad that workers were being retrenched yet there was no visible effort made by the government to see to it that the struggling factories are stable.

Makakole said the desperate situation in the clothing and textile industry could only be reversed if new investors come in.

There were many factories in Butha Buthe nearing completion but they did not have water and electricity, he pointed out.

"The question is, how will they work without such vital utilities?" he quizzed.

Makakole also said the government had in January this year promised to reopen factories that were closed in Maseru in two months but this never happened.

"They (government) spokes about it at the beginning of the year but now its four months and we're still waiting," he noted.

He added that the government should assist in sources markets for local products beyond South Africa and United States.



# Health workers go on strike

ealth professionals say they will not be reporting for duty from today due to non-payment of their salaries for the month of April.

The health professionals join a growing chorus of criticism from discontented civil servants who have been incessantly firing a broadside at the government over the past week for its failure to pay their salaries for the past month.

The ministry of public service, labour and employment notified civil servants through a circular dated April 21 2023, of what it called 'a possible delay' in the payment of salaries for April due 'systematic and technical problems encountered during implementation of new codes for merged ministries'.

In a statement issued on Wednesday this week, the Coalition of Health Professionals accuses the ministry of not communicating the reasons for the non-payment of salaries to health workers.

"We were last paid our salaries on March 16 2023, but the ministry failed to meet its obligation for the past month and without any explanation and communication on what could possibly be the hindrance to other salaries being paid.

"The livelihoods of our members depend on their salaries and failure to get them has caused some of our members to lose their rented accommodation. They are also struggling to even make it to work because they do not have the funds to do so, and as such, we will not be re-

porting to duty from Friday until the matter is resolved by the ministry of health," the statement read.

The Coalition of Health Professionals' decision comes shortly after the Lesotho Public Service Staff Association (LEPSSA) had accused the government of disregarding workers' rights.

LEPSSA's secretary-general Motebang Leboela, told theReporter on Tuesday: "The sad part is that the government did not bother to involve workers' unions in their decision even though it knows that workers will always seek our intervention every time they are failed."

Leboela lamented that as other workers were celebrating Workers Day on Monday, civil servants were morose because they had not been paid their salaries.

She added that some of them could not even make it to functions organised to celebrate Workers' Day due to lack of funds and the stress of knowing they were not able to meet their daily needs.

"Some of the workers have bank loans and any delay of salary payment results in penalties from the banks."

In a similar vein, the Lesotho Nurses Association announced on Sunday that nurses were not in a position to celebrate because they were not paid.

The association criticised the government for not respecting workers' rights.

"These are signs of a nonchalant government that has no respect for workers," the association said in a statement.

Speaking to the Reporter on Tuesday, the minister of public service, labour and employment, Richard Ramoeletsi, said only three government departments were not paid because they had not submitted their employee lists.

According to Ramoeletsi, government bodies like parliament, ministries of trade, industry,

business development and tourism, natural resources, and health had already submitted their lists.

"Only four government entities were behind but I was told that ministry of health had already submitted its list and, as we speak, Central Bank is already processing their payments. I believe by end of today they would have been paid.

"The merging of government ministries effected by the current coalition government has led to the delay in the payment of salaries for civil servants. As a ministry, we await all the employees' names before we can proceed to compile our payroll which we will then submit to the ministry of finance to make payments.

"This is a three-pronged matter, and if it is incomplete, we will not be able to pay. I am not even blaming anyone, but it is the system," Ramoeletsi noted.

One of the affected ministries is that of trade

and industry. Its public relations officer, 'Mantletse Maile, disputed the minister's claim, insisting the ministry of trade had submitted its list of employees on Friday last week.

Maile told this publication that ministry of

Maile told this publication that ministry of trade officers learned from treasury that all other lists had already been submitted to the Central Bank of Lesotho.

Meanwhile, the Reporter yesterday learned that nurses had still not received their salaries.

It also discovered that even some ministry of communications, science, and innovation employees were among ministries that had not been paid.



# Africa's agricultural paradox — so much potential for farming, so many barriers to success

frica is a continent that struggles with high unemployment, poverty and low economic growth. Growth in agriculture is two to three times more effective at reducing poverty than an equivalent amount of growth generated outside agriculture.

Agriculture is an essential driver of employment and economic activity in most African countries. For example, roughly 60% of the population of sub-Saharan Africa is engaged in smallholder farming. About 23% of sub-Saharan Africa's GDP comes from agriculture.

However, the strategic role of the sector as a driver to advance economic development has been hampered by a number of exogenous factors. The Russia-Ukraine war and Covid 19, continue to compromise the resilience of its agricultural sector.

These major challenges come against the backdrop of existing problems that have already been affecting the agricultural sector in the past.

# These include:

- Climate change with its associated shocks, such as frequent droughts, flooding, famine, etc:
- Biosecurity, primarily the weaknesses in managing animal diseases, eg, highly pathogenic avian influenza (HPAI), foot and mouth disease (FMD), and African swine fever;
- We see pest infestations, such as the fall armyworm (FAW), and locusts regularly in the East African region — whose frequency and intensity is also emerging as a consequence of changing weather patterns;
- Low farm and off-farm productivity remains a major challenge and will continue to be a constraint even in this environment where most people are excited about the promise of the African Continental Free Trade Area (Af-CFTA);
- Lack of adequate infrastructure, which increases transaction costs for farmers and agribusinesses operating in the continent

of Africa;

- Conflicts or wars, like what we are witnessing in Sudan, Mozambique, and parts of West Africa;
  - Fragmented food value chains; and
- More recently, rising input costs, partly because of the Russia-Ukraine war.

Therefore, we need to tackle these challenges collectively and in a holistic fashion in order to maximise the value of the agricultural sector in Africa.

We are a continent that struggles with high unemployment, poverty and low economic growth. We know from the literature that growth in agriculture is two to three times more effective at reducing poverty than an equivalent amount of growth generated outside agriculture. Moreover, the advantage of agriculture over non-agriculture in reducing poverty is largest for the poorest individuals in society and extends to other welfare outcomes, including food insecurity and malnutrition.

So, what to do with all these challenges?

There are some policy considerations that I believe African agricultural ministers can reflect on. Four overarching issues should remain critical priorities for African governments:

First, African governments must improve land governance, which is fundamental for long-term investments. We know that roughly 86% of all the continent's rural land plots are still unregistered. We cannot expect any meaningful levels of investment, infrastructure development and farm productivity improvements in an environment in which land ownership and use rights are inadequate.

To use South Africa as an example — in parts of the country with strong property rights, we continue to see secure use and ownership rights that provide incentives to engage in robust agricultural activity, which essentially sustain our food security and exports.

Meanwhile, in the former homeland regions of South Africa, with weak land governance, such robust agriculture is non-existent to a large extent. Of course, I am simplifying a more complicated argument, because these rights need to be couched in other important

variables and factors such as infrastructure, institutions, skills, and agricultural finance, but you get the main point.

Second, African governments must create an enabling policy environment. This includes clear competition and merger regulations, tax incentives for SMEs, a regulatory environment that promotes quality standards in input and output markets, predictable trade policies, digitalisation of customs procedures, and harmonisation of border regulations.

Third, once we have the above matters adequately addressed, we could focus on attracting long-term investment in Africa's agriculture. Here, I am not only talking about the private sector investments by local (MSMEs) and global investors, but also public sector investments, i.e. public infrastructure expansion of border infrastructure, roads and connectivity (IT)

Fourth, we must also address the issue of informality in Africa's agriculture and food industry. In an article I co-authored with agricultural economists Edward Mabaya of Cornell University and Lulama Ndibongo Traub of Stellenbosch University, we noted that "across all of the continent's regions, except southern Africa, informal employment as a percentage of total employment in the agricultural and non-agricultural sector is above the global average of 64% for emerging and developing markets economies.

"More than 80% of the continent's population relies on open-air, largely informal markets for their food. Poor sanitary conditions in many of these markets raise concerns about food safety for households that depend on them.

"Suppose African countries are to ensure resilient and sustainable agrifood systems. In that case, they must upgrade food value chains by shifting production and employment from informal micro-enterprises to formal firms offering wage employment with income security and health benefits for employees. This will also ensure improvements in food safety within the system."

In essence, we need policy reform and implementation, investments, and technical innovation, which lead to competition and efficiency gains in Africa's agriculture.

Notably, African governments, this time around, should increase the pace of policy reform to continue stimulating private-sector investments. They must also ramp up public investments to strengthen regional food value chains, AfCFTA implementation, etc. DM

# **Driving financial literacy in Lesotho** - Money Month Campaign 2023

oor money management and low financial literacy are among the biggest sources of stress for many households in Lesotho. To tackle this, the Central Bank of Lesotho (CBL) in collaboration with players within the financial services industry launched the Money Month Campaign 2023 (MML) in Butha Buthe on Thursday, 27 April 2023. Prior to the launch, I sat down with Ntate Ephraim Moremoholo, Chairperson of the National Financial Education Steering Committee (FESC) to unpack what Basotho can expect from the Money Month Campaign 2023.

### TKay: For Basotho who do not know you, who is Ntate Moremoholo?

Ntate Moremoholo: I am the Chief Corporate Communications at the CBL and the Chairperson of FESC. This committee coordinates all financial literacy activities in Lesotho, comprising government ministries, development partners, the CBL as the secretariat of the committee, mobile money issuers. micro-finance, banks, insurance and asset management companies and pension funds.

### **TKay: Why is the Money Month Campaign** important Basotho?

Ntate Moremoholo: FESC's responsibility is to educate the public on financial matters. As a country, we also have a financial inclusion agenda, whereby the Government of Lesotho is committed to ensuring that every Mosotho understands and has knowledge of available products and services within the financial sector. The hope is that when people are informed and know about these financial products and services, every Mosotho will be able to use them. This is important because it is also part of the Global Financial Inclusion agenda.

# TKay: Why does Lesotho have to celebrate the campaign for a month instead of a week?

Ntate Moremoholo: Lesotho is unique, with a mountainous terrain where some places are very remote



and hard to reach. Based on our unique circumstances, the campaign is extended to a month instead of a week, so that we have enough time to reach and educate Basotho, especially those in remote areas. We have also adopted the same theme as the Global Money Week (GMW) 2023, 'Plan your money, plant

### TKay: What are some of the challenges facing Basotho?

Ntate Moremoholo: Some of the challenges facing Basotho are high levels of indebtedness, people living beyond their financial means, and not budgeting, saving or investing for the future. Furthermore, some Basotho do not aware of available products and ser-

### TKay: Which target groups does the campaign aim to reach?

Ntate Moremoholo: The GMW campaign focuses mainly on youth and children. What makes the MML different is that it does not only focus on youth and children but includes all stakeholders participating in the financial sector for example youth in business, people with disabilities, women's associations, public servants, teachers and the business community.

# TKay: What does the theme 'Plan your money, plant your future' mean to you?

Ntate Moremoholo: Translated to Sesotho, 'Rala chelete ea hao, Roalla le sa sele'. For me, it is important to remember that it is never late to acquire financial literacy skills and knowledge about managing money. It is important to take responsibility for your finances and to make sound financial decisions.

# Gem Diamonds 13% Revenue Hike in Q1

Gem Diamonds announced a 13 per cent increase in Q1 rough sales from Letseng, in Lesotho, the highest dollar per carat kimberlite diamond mine in the world. It raised \$36.7m. The London-listed miner said it achieved an average \$1,431 per carat during the quarter to 31 March 2023, virtually unchanged from the previous quarter. The highest price paid was \$282,889 per carat for a 6.63-carat pink diamond, the third highest dollar per carat achieved for a LetÅieng rough diamond.

A 58.07-carat Type Ila white diamond sold for \$34 441 per carat, the company said in a trading update. Seven diamonds sold for more than \$1m each during the quarter, A 122 carat Type II white diamond recovered in Q1 will be sold in Q2. The total number of carats sold during the quarter was up 14 per cent to 25,687 and sales were up 13 per cent

In March Clifford Elphick, the company's CEO, said: "Demand for Letseng's large, high-value diamonds remains strong. The re-opening of China, the second largest diamond market, is expected to pave the way for a rapid rebound in economic activity, which bodes well for diamond prices in 2023.'



here are things that I keep hearing and reading. The first is that digital is the future, and the second is that AI is going to take our jobs and even ruin our lives. Whether it's Mac G and Sol and their constant clamour to prove more viable than radio, or Koshiek (Fintech disruptor) illustrating why the platforms they've designed are smarter or more sustainable in the future.

Either way there is very definitely a competition of views with regard to the tech boom we are experiencing. I'm an early AI adapter in the sense that I've started using ChatGPT. As I said recently one of my columns was written by the AI bot. I have recently enlisted it to help me write a business plan for a budding young business, and will surely use it again for a task like that...

Geoffrey Hinton the former Google AI head, resigned last week citing his discomfort with the pace at which the technology was progressing and the lack of checks and balances. It is his fear that in its new guise the tools will get in to the wrong hands and bad things will happen.

This is obviously a serious concern from someone well positioned to register such views. Even with all of that in mind I'm upbeat about the future in an AI co-dependent world. Hinton says that computers will very definitely be clever than us, sooner than we think. On Twitter the folks are worried that humans will be replaced by bots. Again, said concerns are perhaps spurred on by lived experience. Mechanization hasn't been kind to many a worker, so why would this be any different?

I speak as a laymen and can only use my rudimentary knowledge and experience on the matter. In order to coax ChatGPT in to writing my column with (rather than for) me I had to insert about six weeks' worth of questions and answers in order for the algorithm to do what I wanted it to. I was training it, not the other way around. Also, when I read back the piece it still didn't quite have the cadence nor stylistic feel I required. The algorithm knew the words I wanted but still couldn't arrange them quite how I needed.

What I'm trying to say is, AI was a really great assistant but wasn't quite able to do my job yet... This last week the music streaming site Spotify released a hip hop track by the AI version of Drake. To my uncultured ear it sounded exactly like a production the Canadian star would make, but to better trained folks they discarded and disregarded it out of hand. There was I suppose, a nuance missing. And So, I go back to my thoughts that perhaps this tool is going to be the greatest assistant ever. It'll input a load of data collated in a short space of time and then the human will add the nuance and experience. AI will make our lives easier, without necessarily "taking our livelihoods".

The future is now. Digital innovation and tech-

nological disruption isn't coming. It isn't somewhere down the line, no, it's here, right now! Lesotho is a little different in general owing to its least developed status economically but even still tech has found its way into many daily lives. There are kids who live on the internet, eking out economic prosperity in the met averse proving to us sceptics that it isn't some gimmick or passing fad but rather a real alternative. There are folks tuning in to Sky Alpha HD every day to hear what our crazy on air personalities are thinking. Whatsapp and Facebook have in excess of 500 000 Basotho using them daily. The digital revolution isn't an idea that's coming in ten or so years' time. It is well and truly upon us.

Aside, podcasters selling the doom and gloom of the end of radio continue to be off the mark. In my view they ought to figure out a way they can work in tandem with mainstream media rather than trying to antagonize those traditional media. There is growth in collaboration, and especially in cross pollination. Dr Sizwe Mpofu-Walsh has figured it out, I hope the others will too. The "us and them" mentality the likes of Podcast & Chil seem to have taken is good for soundbites but less so for business from my purview...

That said, I hope we'll embrace the possibilities the future offers up, and rather than be cynical, perhaps an open mind is a better response to these developments.



he Embassy of Italy Pretoria is bringing Dante's Ballet Inferno to Lesotho, a music, poetry and comedy performance set to take place on May 17 2023 at 'Manthabiseng Convention Centre free of charge

According to the choreographer of Ballet Inferno, Mario Gaglione, the musical is a result of a 2021 collaboration between Joburg Ballet and the Pretoria-based Italian Institute of Culture.

In an interview with the Reporter this week, Gaglione said he was approached by the Institute on the occasion of the 700-year anniversary of the death of Dante Alighieri, one of the fathers of the Italian literature of the XIV Century.

Mario said Dante Alighieri's famous masterpiece "The Divine Comedy", has proven itself to be a timeless piece of art and it is still very relevant musical today.

"Its first section, Inferno, sees the protagonist, Dante himself, in a journey through hell. Parts of this section have been translated into the languages of Zulu, Sesotho, Xhosa and Afrikaans.

"This has been the inspiration behind the creation of the ballet and it represents one of the key elements, together with the wonderful score by Hans Zimmer, which accompanies the story beautifully," he indicated.
